**AREAS OF COOPERATION**

VNASCEN and DYPIMED agree to the following goals and objectives in order to pursue the academic collaboration programme:

**a) Campus Visit**

VNASCEN and DYPIMED shall allow research students of the respective institutes to visit their campuses in the form of institute visits (one day visit with an orientation and host family session).

**b) Joint Research and Consultancy**

This assistance shall not be limited to and include guidance during Summer Internship Program, the Research Project, doctoral research and related activities.
- **Library Share:** Faculty and Students from both VNASCEN and DYPIMED will have full access to the library and related infrastructures. Each Institute on a joint venture provide full access to library facility of the other Institute for research related work. Library staff from both institutes will conduct regular meetings for exchange of knowledge transfer on latest journals, magazines, databases and developments in library science. The process and policy for accessing study material shall be mutually agreed to by both institutes.

### Purpose:

1.2 The parties aim to facilitate the exchange of faculty members and students to enhance teaching, research, and cultural understanding.

### Areas of Collaboration:

#### 2.1 Faculty Exchange:

2.1.1 Institute Of Business Management & Research and Dr. D. Y. Patil Institute of Management agree to facilitate the exchange of faculty members for short-term visits or longer-term assignments, subject to mutual agreement and availability of resources.

2.1.2 The faculty exchange will focus on sharing expertise, delivering lectures, conducting research, and participating in academic activities that benefit both institutions.

2.1.3 The specific details regarding the duration, responsibilities, and financial arrangements for faculty exchange will be mutually determined and documented in separate agreements.

#### 2.2 Student Exchange:

2.2.1 Institute Of Business Management & Research and Dr. D. Y. Patil Institute of Management will promote student exchange programs to foster intercultural learning and academic enrichment.

2.2.2 The student exchange programs will allow students from both institutions to study at the partner institution for a specified period, typically one or two semesters, while earning credits that contribute to their respective academic degrees.

2.2.3 Both parties will establish clear guidelines and procedures for student selection, academic requirements, credit transfer, accommodation, and other necessary arrangements to ensure a smooth exchange experience.

2.2.4 The financial responsibilities, including tuition fees, living expenses, and travel costs, will be determined by mutual agreement or in accordance with the existing policies of each institution.

### Implementation and Administration:

3.1 A designated representative from each institution will be responsible for overseeing the implementation and administration of this MOU.

3.2 Regular communication channels will be established between the respective representatives to coordinate and monitor the progress of the exchange programs.

3.3 The parties agree to periodically review and evaluate the effectiveness of the exchange programs and make necessary adjustments to improve their quality and outcomes.

### Intellectual Property and Confidentiality:

4.1 Each party shall respect the intellectual property rights of the other party and ensure that any research, materials, or intellectual contributions resulting from the collaboration are appropriately acknowledged and protected.

4.2 Any confidential information shared between the parties shall be treated as such and used solely for the purposes outlined in this MOU.

### Duration and Termination:

5.1 This MOU shall come into effect on the date of signing and shall remain valid for a period of two years.

5.2 Either party may terminate this MOU by providing written notice of termination at least one month in advance.

5.3 Termination of this MOU will not affect ongoing exchange activities; however, it will prevent the initiation of new exchanges unless otherwise agreed upon.
