12. Ensuring the financial sustainability of the institution by developing sound financial plans, diversifying revenue streams, and optimizing resource allocation.



6. The committee considers methods for evaluating the impact of club activities on student engagement, personal development, and the overall college environment. Metrics and feedback mechanisms may be discussed.
7. An overview of the existing canteen facilities is presented. Committee members discuss the current state of the canteen, including services offered, seating capacity, and overall satisfaction among students and staff.
