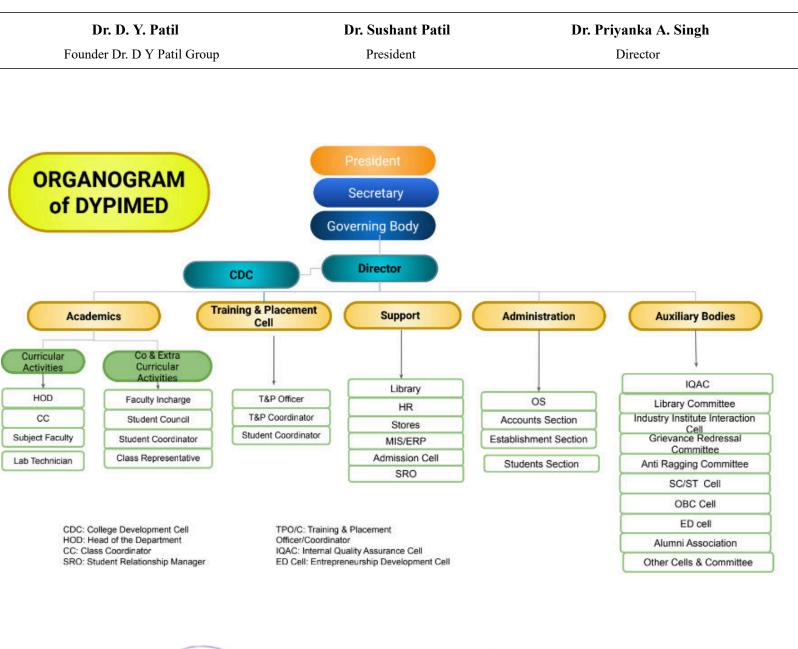

the actions implemented and the present status of the matters discussed during the preceding meeting. Subsequently, the members collectively endorsed the minutes of the previous CDC session.

- 3. The Secretary informed the external members about the establishment of IQAC in College and then highlighted the seven criteria of the NAAC self-study report.
- 4. It was emphasized that education should be job-oriented and it should also meet the demands of students coming from lower income strata of society.
- 5. The Director updated all the members about various activities conducted in the college: a. Students oriented activities: Inter collegiate Fest, Annual day (Cultural), Annual sports day, Days Celebration, Guest Lectures, Exam preparation, Attitude change, Conferences and Workshop: State Level Workshop on Faculty Skill Enhancement, Industrial Visit etc.
- 6. Members also discussed the Synergy club of DYPIMED.
- 7. The Director also informed that the work for NAAC accreditation is in process.
- 8. The HOD of MCA Dr. Ashwini has discussed the process followed by the institute on the feedback received from the students and also informed the members about the planned parents meet.
- 9. The Director discussed with all the members regarding the requirement of staff.
- 10. The Industry representative asked the members of the institute to concentrate on the Development of students in light of soft skills and corporate readiness. The Management agreed to the committee to take required action.
- 11. The CDC committee also discussed various heads in the proposed budget which includes, high end computers and other infrastructure requirements and gave its recommendation for approval.
- 12. To improve the students' performance in upcoming examinations, members suggested that measures like Remedial coaching by faculties, Assignment writing should be initiated.
